VIII. New Business:

A. Proclamation – PA 529 – Commitment to College and Career Saving in Mifflin County

PA 529: COMMITMENT TO COLLEGE AND CAREER SAVINGS IN MIFFLIN COUNTY

WHEREAS, Mifflin County Commissioners believe that financial planning is a first step to ensure a brighter future for Mifflin County's children and families and should have a plan for college and career training; and

WHEREAS, Employers have a responsibility to ensure they are supporting employees with children by implementing new policies and reviewing and updating existing ones; and

WHEREAS, Children with a college and career savings are more likely to attend college or gain expertise in a trade, promoting economic growth and making communities stronger; and

WHEREAS, The Pennsylvania Treasury Department administers the PA 529 Savings Program for families with children, providing a way for individuals to save tax-free for college and careers; and

WHEREAS, At no cost, employers can help empower employees with children by providing awareness of PA 529 and facilitating automatic payroll deductions to employees' PA 529 accounts; now therefore be it

RESOLVED that the Mifflin County Board of Commissioners is partnering with the Pennsylvania Treasury Department to promote financial planning for college and career training, and will:

- Make the PA 529 program known to all county employees and offer each the ability to contribute to PA 529 accounts via payroll deductions; and
- Set precedent for other employers in Mifflin County, thus encouraging them to follow this example by offering the same consideration to their employees.

Proclaimed this 16th day of May, 2024.

Mr. Larry Booker from the PA Treasury Department presented information on PA 529 Savings Plans. Mr. Booker explained these plans allow families to save for college or other career training. They are interest bearing savings accounts that can be closed at any time. Contributions are deducted after tax so are tax free. Withdrawals made for non-educational expenses may be subject to taxation. Accounts can be set up by any family member and contributions can be made by any family or friends. There is no cost to the county to set up automatic payroll deductions for an employee to contribute to a 529 plan.

Motion was made by Commissioner Kodish to approve. Commissioner Wise seconded the motion. The motion was unanimously approved.

B. Mifflin County Correctional Facility inspection

Warden Kormanic stated the MCCF Title 37 inspection was completed on 4/31/24. The facility was found to be in full compliance. Due to this, they will not have to undergo another inspection until 2026. Mr. Kormanic recognized CO Mitchell and Nurse Price for their efforts in preparing the facility for the inspection stating it was because of their efforts that the inspection went so well.

Motion was made by Commissioner Kodish to approve. Commissioner Wise seconded the motion. The motion was unanimously approved.

F. Indigent Defense Grant Application for the period July 1, 2024 through December 31, 2025-\$111,973.00

Public Defender Shawn Curry provided background for the need for the grant siting the increased volume of cases handled by the Public Defenders office annually and the small number of staff. The total volume of cases for last year exceeded 500 cases.

Mr. Curry stated there are three objectives for the grant funds. First, to purchase case management software for better management of cases. The office does not currently have a software program. Second, he would like to add a part-time clerical position within the office to assist the current full-time employee. It is undetermined at this point how duties would be divided between the two. Lastly, if there is enough funding left he would like to add a part-time Assistant Public Defender to assist with the caseload.

Motion was made by Commissioner Wise to approve. Commissioner Kodish seconded the motion. The motion was unanimously approved.

G. Subrecipient Agreement with the Geisinger Clinic, on behalf of the Geisinger School of Nursing for a \$100,000.00 grant to support the purchase of a new SIM software/hardware to provide nursing students with training methodology

Planning Director James Lettiere said this grant will allow the students of the new nursing school to have the most current technology to learn with. This grant will expire December 31, 2024. Mr. Lettiere noted the official ribbon cutting for the Geisinger School of Nursing will be held tomorrow May 17, 2024.

Motion was made by Commissioner Wise to approve. Commissioner Kodish seconded the motion. The motion was unanimously approved.
