Planning Director Lettiere gave an update on the Mifflin County Comprehensive Plan. Michael Baker International is the consultant and is heading the plan update. A Planning Advisory Committee was formed and consists of members from each municipality, as well as stakeholders from the community. The committee members role was to provide recommendations for a community survey. There were approximately 700 responses for the survey. A plan will be made from the results of the surveys to create 4-5 goals and objectives that are implementable over the next 10 years.

A grant was received from the Commonwealth for approximately half of the cost (\$68,000) for the plan.
