

**Second Public Hearing Notice for
Mifflin County and on Behalf of The Armagh, Brown, Derry and Granville Township Supervisors

For the FFY 2023 Community Development Block Grant (CDBG) Program**

Notice is hereby given that the Mifflin County Commissioners and on the behalf of the entitlement communities of Armagh, Brown, Derry and Granville Townships, and Lewistown Borough, will conduct a public hearing at 9:00 a.m. on October 5, 2023 at the Mifflin County Courthouse, Meeting Room A, 20 North Wayne Street, Lewistown, PA 17044. The purpose of this hearing is to obtain citizen views, comments or grievances on the proposed projects and use of the FFY 2023 CDBG funds, which includes the entitlements allocations. This hearing is accessible to individuals with disabilities and/or for persons with limited English proficiency. The projects proposed for funding and to be discussed at the hearing include the following. The proposed activities plan for no displacement of any persons or affordable housing units. At least 70% of the funds will benefit low-to-moderate income residents.

Furthermore, the County Commissioners shall not disclose any information which may, in the opinion of the County Commissioners, be deemed of a confidential nature.
