A. Election update

Commissioner Kodish gave a reminder that October 21st is the last day to register to vote in the November Election. Also, October 28th is the last day to request a mail-in ballot. The Elections office will be open until 5:00 pm on both those days.

To date 3127 mail-in ballots have been requested in Mifflin County. Ballots are expected to be mailed out the first week of October at the latest.

B. Proclamation – September, 2024 is Hunger Action Month

2024 Hunger Action Month Proclamation

WHEREAS, Hunger and food insecurity are issues of vital concern in Pennsylvania where, according to Feeding America, over 1.5 million individuals, one in eight Pennsylvanians, and one in every six children experience food insecurity. In Mifflin County one in 7 neighbors and one in 5 children are food insecure; and

WHEREAS, Adequate nutritious food has become more expensive and out-of-reach for many neighbors with food costs increasing more than 27%, leading to record demand for charitable food; and

WHEREAS, Food insecurity, the condition of limited or uncertain access to adequate food, is associated with numerous adverse social and health outcomes and is a critical public health issue; and

WHEREAS, Mifflin County is committed to taking steps to combat hunger in every corner of our communities, and to provide additional resources to those in need; and

WHEREAS, Mifflin County is committed to working with the Central Pennsylvania Food Bank to educate people about the role and importance of food banks in addressing hunger and raising awareness of the need to devote more resources and attention to hunger issues; and

WHEREAS, The Central Pennsylvania Food Bank distributed over 68.5 million pounds of food in Fiscal Year 2024 to Pennsylvanians experiencing food insecurity. In Mifflin County alone, over 870,000 pounds of food were distributed; and

WHEREAS, Public and private entities, including policymakers, business leaders, community activists, farmers, concerned citizens, and hunger relief organizations, must collectively work to address food-insecurity within the Commonwealth; and

WHEREAS, The month of September has been designated nationwide as "Hunger Action Month" to raise awareness of the issue of hunger and mobilize our legislature and the public to help end hunger in America; therefore be it

NOW, THERFORE, We, the Mifflin County Commissioners, do hereby recognize September 2024, as *HUNGER ACTION MONTH* in Mifflin County, Pennsylvania, and we call this observance to the attention of our citizens.

Maria Disabella thanked the Commissioners and recognized Melissa Stewart and Robin White from Mifflin County Human Services for their efforts. Ms. Disabella noted 1 in 7 people are hungry and without the support of the County the Food Bank would be unable to meet the needs of the community.

Ms. Stewart added there are approximately 600 families in Mifflin County considered food insecure. The Food Bank strives to eliminate those needs. Ms. White stated there is a food calendar posted monthly on the County website listing locations for food pick up.

F. Resolution No. 46 of 2024 Fair Housing Policy for the County of Mifflin and on behalf of the Armagh, Brown, Derry and Granville Township Supervisors and the Lewistown Borough Council

FAIR HOUSING RESOLUTION No. 46 of 2024

LET IT BE KNOWN TO ALL PERSONS of Mifflin County and Mifflin County on behalf of ('obo') Armagh Township, Brown Township, Derry Township, Granville Township, and Lewistown Borough that discrimination in the sale, rental, leasing, financing of housing or land to be used for construction of housing, or in the provision of brokerage services because of race, color, sex (including gender identity and sexual orientation), national origin, religion, familial status (families with children), or handicap (disability) is prohibited by Title VIII of the Civil Rights Act of 1968 (Federal Fair Housing Act) and the Pennsylvania Human Relations Act adds the additional protected classes of age, ancestry and use of guide or support animals because of the blindness, deafness or physical handicap of the user or because the user is a handler or trainer of support or guide animals. It is the policy of Mifflin County and Mifflin County 'obo' Armagh Township, Brown Township, Derry Township, Granville Township, and Lewistown Borough to implement programs to ensure equal opportunity in housing for all persons regardless of race, color, sex (including gender identity and sexual orientation), national origin, religion, familial status, handicap, age, ancestry and use of guide or support animals because of the blindness, deafness or physical handicap of the user or because the user is a handler or trainer of support or guide animals. Additionally, it is illegal to retaliate against a person who has filed a fair housing complaint or assisted in a fair housing investigation. Therefore, Mifflin County and Mifflin County 'obo' Armagh Township, Brown Township, Derry Township, Granville Township, and Lewistown Borough does hereby pass the following resolution.

BE IT RESOLVED, that within available resources Mifflin County and Mifflin County 'obo' Armagh Township, Brown Township, Derry Township, Granville Township, and Lewistown Borough will assist all persons who feel they have been discriminated against because of race, color, sex (including gender identity and sexual orientation), national origin, religion, familial status, handicap, age, ancestry and use of guide or support animals because of the blindness, deafness or physical handicap of the user or because the user is a handler or trainer of support or guide animals to seek equity under federal and state laws by filing a complaint with the local Fair Housing Officer, Pennsylvania Human Relations Commission and the U.S. Department of Housing and Urban Development, whichever is chosen by the person filing the complaint.

BE IT FURTHER RESOLVED that Mifflin County and Mifflin County 'obo' Armagh Township, Brown Township, Derry Township, Granville Township, and Lewistown Borough shall make publicly known this Resolution and through this publicity shall cause owners of real estate, developers, and builders to become aware of their respective responsibilities and rights under the Federal Fair Housing Act, the Pennsylvania Human Relations Act, and any local laws or ordinances.

FURTHER ACTION will at a minimum include, but not to be limited to:

- (1) Publicizing the name and contact information of the local Fair Housing Officer, or publicizing the Pennsylvania Human Relations Commission and U.S. Department of Housing and Urban Development Regional Office as the acting local Fair Housing Officer, which will include the process to file a complaint if a person feels they have been discriminated against in housing in any manner and other applicable fair housing information through local media and community contracts; and
- local media and community contracts; and
 (2) Conduct at least one fair housing activity annually to better inform the public of their rights under the Fair Housing Law and Pennsylvania Human Relations Act; and
- (3) Use the fair housing logo on all materials dealing with housing programs such as but not limited to:
 - a. Public advertisements for vacancy or discussing the program
 - b. Applications for assistance
 - c. Contracts
 - d. Municipal letters dealing with the federal programs

WHEREAS, Mifflin County must designate a Section 504 Compliance Officer who will serve as the Mifflin County's designated representative for any and all complaints regarding 24 CFR Part 8 of the Code of Federal Regulations and adopt grievance procedures;

WHEREAS, Mifflin County has begun public outreach and consultation with interested parties to solicit input and feedback regarding Mifflin County's compliance with administrative rules and regulations related to Section 504 of the Rehabilitation Act of 1973;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Mifflin County as follows:

- Director of Maintenance, Lonnie Griffith, of the Mifflin County Maintenance Department is hereby designated as Mifflin County's Section 504 Compliance Officer.
- Mifflin County has adopted a grievance procedure for any and all complaints regarding accessibility to all Mifflin County owned facilities and programs.
