VIII. New Business:

A. Domestic Violence Awareness Month Proclamation

Rebecca Wills from The Abuse Network stated abuse is more prevalent for women than women's health issues and goes largely unreported. Community members can help by volunteering, donating, or by contacting their legislators.

Domestic Violence Awareness Month Proclamation for October 2024

Whereas domestic violence remains a pervasive issue across Mifflin County, the United Sates and the world with implications for personal and community health; and

Whereas, domestic violence does not discriminate and touches all communities regardless of age, race, disability, gender identity, or socioeconomic status; and

Whereas, in Mifflin County, every day people are physically abused by an intimate partner; and

Whereas, considering medical expenses, lost productivity, legal costs, and property loss and damage, domestic violence costs victims nearly \$82,000 over their lifetime and collectively costs the United States \$3.6 trillion; and

Whereas, research shows that by creating communities where people are connected, supportive and care for one another can reduce incidents of domestic violence; and

Whereas, every day in Mifflin County individuals and organizations play a part in supporting people impacted by domestic violence, providing services including therapeutic, legal, educational, housing, advocacy, and medical services;

NOW, THEREFORE BE IT RESOLVED that the Mifflin County Board of Commissioners, on behalf of all residents of Mifflin County, does hereby proclaim October 2024 as

Domestic Violence Awareness Month

in Mifflin County and urges all residents to become involved in efforts to prevent and respond to domestic violence and recognize the impact of domestic violence in our community.

"NATIONAL DISABILITY EMPLOYMENT AWARENESS MONTH" October 2024

WHEREAS October 2024 marks the 79th anniversary of National Disability Employment Awareness Month; and

WHEREAS the purpose of National Disability Employment Awareness Month is to educate about disability employment issues and celebrate the many and varied contributions of America's workers with disabilities; and

WHEREAS the history of NDEAM traces back to 1945, when it started as a week and focused only on people with physical disabilities.

WHEREAS, Later, it expanded to a full month, and its name and scope evolved to acknowledge the importance of increasing the workforce inclusion of people with all nature of disabilities.

WHEREAS, Workplaces welcoming of the talents of all people, including people with disabilities, are a critical part of our efforts to build an inclusive community and strong economy; and

WHEREAS Activities during this month will reinforce the value and talent people with disabilities add to our workplaces and communities and affirm Juniata Valley Behavioral and Developmental Services' commitment to increasing access to good jobs for all workers, including disabled workers.
